VOITURE LOCALE CERTIFICATION OF DELEGATES AND ALTERNATES

This is to certify that the following delegates and alternates are paid up members of Voiture Locale _____ for the year of _____ and have been duly elected to present our Voiture Locale at the Annual Grande Promenade of the Grande Voiture du Indiana.

Said delegates and alternates have been elected in accordance with Article, Section 3, of the Grande Voiture' Constitution:

"In the Grande promenade, each Voiture Locale – ten members shall constitute a Voiture Locale – shall be entitled to one delegate and one alternate, and two delegates and two alternates for fifty one members; three delegates and three alternates for 101 members; four delegates and four alternates for 151 members; and one additional delegate and one additional alternate for every 50 members thereafter whose current per capita tax – dues – are paid up members have been received by Correspondent National forty-five days prior to the convening of the Grande promenade. Delegates and alternates shall be elected by the paid-up membership of a Voiture Locale at a regular meeting of the Voiture Locale and certified to the Grand Correspondant on forms furnished by the Grande Voiture not less than thirty (30) days prior to the Grande promenade. Any Voiture Locale failing to comply with the terms of this section shall be denied representation at the Grande Promenade except upon written consent of the Credentials Committee of the Grande Promenade after a good and just cause has been shown for such failure."

Also, Section 7 reads as follows:

"If dues or any other indebtedness of a Voiture Locale owing to the Grande Voiture or to Voiture Nationale remains unpaid within fifteen (15) days of the convening of the Grande promenade, the delegates of such Voiture Locale shall be seated at the Grande Promenade only upon the recommendation of the Credentials Committee and upon favorable vote of the Grande Promenade."

Also, the Constitution of the Grande Voiture as amended at the 69th Grande promenade requires that **ALL DELEGATES, ALTERNATES AND VOYAGEURS ATTENDING THE GRANDE PROMENADE TO REGISTER AND SHOW CREDENTIALS**, before being admitted to any session of the Grande promenade.

Voiture Locale _____ according to the membership received by the Grande Correspondent forty-five (45) Days prior to the convening of the Grande Promenade is entitled to _____ delegates and _____ Alternates at the Annual Grande promenade.
